**CALL TO ORDER** – Harry Matthews, President, called the meeting to order at 5:08 p.m. Roll was called and a quorum was present. Board and audience introduced themselves.

### **CONSIDERATION OF MINUTES**

### **ANNOUNCEMENTS:**

- Bob Hamilton noted that North Bay Regional Center will host a Town Hall Meeting in Santa Rosa on March 9 at 9:30 at Cook Middle School in Santa Rosa and one in Napa on March 16 at 9:30 at ParentsCAN. The meeting is to learn about NBRC services, the role of the Service Coordinator, and what can be expected.
- Angel Giroux-Greber noted that the Child Care Forum Part 3 will be held February 25<sup>th</sup> from 6:30 to 8:30 p.m. in conjunction with the Children's Nurturing Project and Local Parents Group.
  - ✓ Patty Hidalgo, parent, noted the first two Child Care public forums were specific to the monetary gap for special needs child care in Solano County. The third forum is sponsored by Supervisor Skip Thompson and Assembly Member Jim Frasier. The goal of the forum is to find a solution for the gap amongst all providers and agencies. Patty formally invited Bob Hamilton to be a part of the forum. Pamela Madden Krall, Pam Porter, and Margi Stern attended the last two forums.

- ✓ Lucia Bogacki, parent, noted that the forum was formed because many Solano County families have the burden of caring for special needs children and wants the community to support families as much as possible. Many families do not receive respite due to In Home Support Services (IHSS). There are multiple issues preventing families from obtaining a continuum in services.
- Elizabeth Clary, UCPNB, announced the Sonoma County Transition Faire is scheduled to take
  place on February 10, 2016 from 4:00 7:00 p.m. at the Sonoma County Office of Education in
  Santa Rosa. The Transition Faire assists parents with resources in the community when their
  children prepare to graduate from high school.
- Bob noted the New Day Conference in Los Angeles sponsored by the ARC California. More information forthcoming.

#### FEATURE PRESENTATION: NBRC Dental Coordinator - Alisha Gutierrez

Deanna Heibel, NBRC Associate Director, Clients Services, introduced Alisha Gutierrez NBRC's Dental Coordinator. NBRC has been working with Alisha for approximately 15 years. It began as a Wellness Grant and once the grant ended, Alisha became a vendor. Alisha is a very strong advocate not only in NBRC's catchment area but in Sacramento and in maintaining dental services in our community. Alisha provided a brief overview of current events in the community.

- NBRC is fortunate to have dental coordination services and the ability to advocate for clients. NBRC is one of the only Regional Centers in Northern California to utilize Dental Coordination services which has enabled NBRC to have hospital based dental programs, a connection with the community/state representatives, and the ability to have a voice. Alisha noted that she is part of several groups that advocate for clients who have in turn shared their testimonies and concerns with the Little Hoover Commission. The Little Hoover Commission is an independent state oversight agency whose mission is to investigate state government operations and through reports, recommendations and legislative proposals promote efficiency, economy and improved service. The Commission is looking at dental services for Californians including people with developmental disabilities.
- In May 2014 Sutter Memorial Hospital announced that they would be discontinuing all dental services for clients. This announcement stirred up a fear amongst clients and program directors. Senator Steinberg developed a program that was able to keep Sutter Solano open to NBRC's more severely compromised clients that cannot be served in an ambulatory setting. The Department of Health Care Services continually stated that they did not see the biggest issue as access to care or rates. Alisha stressed that the biggest issue the system faces in accessing services for our clients are the low DentiCal and MediCal reimbursement rates. DentiCal and MediCal pays approximately \$.30 on the dollar. By the time lab fees and staff administration costs are deducted there is nothing left for the provider.
- Through advocating with the Little Hoover Commission and the MediCal Dental Advisory Committee in Sacramento, Senator Wolk met with group and instrumental in pulling together Partnership Health Plan, The Surgery Center, Alisha, etc., who were able to develop solutions and obtain a contract between VacaValley Surgery Center and Partnership Health Care Plan. Currently there is a temporary six month contract between the Surgery Center and Partnership Health Care Plan. In order to ensure this contract works MediCal Managed Care System is paying a higher flat rate to the Surgery Center. Hospital dental service is an ongoing task to keep the provider/hospital in place. We have a very good system for treating patients.
- How fast can individual clients be seen? Alisha noted that there are many moving parts to having a patient seen in the office and/or hospital. NBRC assures that every sedation case has a referral and a health history that is reviewed and compared to the criteria the hospital has. Communication with the medical provider is essential to assure everything runs smoothly. There must be a safe anesthesia program available. Having the ability and access to in-office providers needs work. This is a statewide system issue with the low rates as the number one complaint. Others feel that the

- red tape and difficulty in dealing with billing MediCal is a huge issue. Many dentists don't feel adequately trained or comfortable with the "unknown" behaviors of people with developmental disabilities. Dentists are not very well trained in dental school to serve our population.
- The difficulty in attempting to preserve and save hospital services is the fact that there are only a
  few voices that continually attend meetings. Why aren't we hearing from other people? One of the
  solutions in moving forward is to encourage everybody to get involved, i.e., parents, care providers,
  clients, etc.
- NBRC catchment area is largely rural. We don't live in a large metropolitan area where we have access to dental graduates. DentiCal has not increased their rate to their dental providers in over 16 years.
- NBRC is fortunate to have an Executive Director/staff who support the dental coordinator and services for clients more than any other entity in California. The State needs to look at the services and raise the rate for providers.
- Rita Edmonds-Norris volunteered to assist Alisha in her advocacy efforts. Discussion followed.
- VacaValley, Sutter Solano, and Kaiser now see NBRC clients for sedation dental care.
- Bob noted interest in a conversation with Partnership Health Plan. Bob encouraged contacting Senator McGuire and his staff as he is a "welcoming ear" to NBRC needs.
- Harry commended Alisha for her wonderful efforts for our clients.

#### **NEW BUSINESS**

- A. Sonoma County Supervisor Gorin's Request for Support to Transform Sonoma Developmental Center (SDC):
  - Supervisor Gorin and Parents Hospital Association (PHA) are striving to maintain a federally qualified health clinic on the grounds of Sonoma Developmental Center to serve NBRC clients.
  - SDC has approximately 400 residents left at SDC, most of which are served by North Bay Regional Center, Golden Gate Regional Center, and East Bay Regional Center.
  - With a federally qualified health clinic, services can be improved for not only SDC residents but community members.
  - The biggest deterrent of having a clinic located on SDC grounds is the location. It is rurally located with limited bus service available. It will be a multi-year process to achieve. The State has guaranteed that they won't surplus this property when the Center closes. They will work with the County and local governments to determine what the best use of the grounds will be. It will take General Services to lease land to a developer, have an RFP for a developer, have plans approved, have a Steering Committee, etc.
  - NBRC is in support of the concept of a federally qualified health clinic on SDC grounds and has already sent a letter of support. The proposed clinic would serve NBRC's clients as well as those currently residing at the Center. The hope is to capture some of the specialized clinical staff that currently provide services at SDC.
  - Stefan Betts, Director of Sonoma County Health Services, is also very much in support of the concept of establishing a health clinic. Discussion followed.
  - NBRC currently has Requests for Proposal (RFPs), one of which has been approved to develop two four-bed crisis homes in the community. Discussion followed.
  - Many NBRC clients have mental health issues but no diagnosis. County Mental Health won't treat
    clients without a diagnosis. It is imperative that clients remain safe and don't end up in a psychiatric
    facility, the criminal justice system, or worse. The goal is for clients to enjoy the experience of the
    community which is what the SDC closure is all about. Discussion followed.
  - Harry and the Board requested Bob Hamilton to draft a response letter to Supervisor Gorin's for review by the Board at the March Board meeting.
- B. Supported Living Contracts Approval Dave Johnson Any contract valued at over \$250,000 is presented to the Board for approval. Michi, Courtney, and team review contracts and send contract requirements to providers, which was completed January 31, 2016 this year. The vendors will receive

a survey and a requirement to submit their audited financials before their contract can be approved. There are 23 Vendors who we pay over \$250,000 per year. \$3.7 Million is the largest SLS contract and \$260,000 is the smallest. Next fiscal year, NBRC will spend between \$38M - \$42M for SLS. Barbara Power suggested the Board convene to understand more of the funding involved in the Supported Living Services (SLS) process. A meeting will be scheduled with Michi and Courtney for funding questions. Discussion followed.

### **COMMITTEE REPORTS**

A. <u>Executive Committee</u> – Harry Matthews - Discussion and seating of Interim Board President. Harry has served his full term of seven years as of February 2016. Margi Stern, Secretary, volunteered to serve as interim President through June 30, 2016. Discussion followed.

B. Vendor Advisory Committee (VAC) - Mike Huckins

The VAC met on Tuesday, January 12, 2016. Please refer to the minutes for the complete report. The December 8<sup>th</sup> VAC meeting was primarily a holiday potluck with advocacy videos and a few announcements.

Community Concerns/Clarifications: Courtney discussed the worksheet and process for submitting negotiated minimum wage rate adjustments.

Group reports were given.

- The Sonoma Vendor Group began discussing their 2016 Legislative Breakfast and is recruiting vendor volunteers.
- NBHC: Mary Eble provided a written report. The Vallejo housing project is slated to start soon. The full report was attached to the VAC minutes.
- SCDD North Bay: Lisa Hooks introduced herself and provided a summary of her experience and offered help to the vendor community.
- Trade Associations: The CDSA Public Policy Meeting will be in Rancho Cordova on February 2<sup>nd</sup>.
   The Annual Public Affairs Meeting/Legislative Meeting is early in March.
- Board Report: Mike reported on the new facility lease, the NBRC Board Meeting schedule and location changes, the New Leaf contract approval and the performance contract diversity measures.
- NBRC/ARCA: Bob reported that ARCA's next meeting is on January 22<sup>th</sup>. Bob discussed the extra
  money that is in the budget, but the Governor is only interested in a general rate adjustment if the
  managed care tax is voted in.
- Dr. Michi Gates:
  - ✓ There is a new wrap around service called Transitional Support Service.
  - Dixon HUD apartments are available.
  - Staff retirements and replacements were announced.
  - ✓ The CPP RFP interview will be completed soon.
  - Maura announced the DSP trainings coming up.
- Disaster Preparedness: The decision tree was discussed and vendors were encouraged to update their contact information before the January 22<sup>nd</sup> emergency communication exercise.

Announcements: Terri Rowland has been named Executive Director of Milestones. The Arc-Solano is hosting its 20<sup>th</sup> annual Oscar gala dinner auction event on 2/28/16 at Zio Fraedo's, Vallejo.

Next VAC Meeting: The next VAC Meeting will be on Tuesday, February 9, 2016.

### **EXECUTIVE DIRECTOR'S REPORT**

Bob Hamilton, Executive Director, Report:

- The Governor's Budget has been briefly introduced. Bob noted the following:
  - ✓ The regional center system is projected to serve more than 300,000 individuals with developmental disabilities and their families in the budget year.
  - ✓ 847 remaining in the Developmental Centers.



- ✓ The 16/17 budget includes \$6.4 Billion, \$3.8 Billion for the General Fund. The rest is from the Federal Government with various waivers NBRC has.
- ✓ Sonoma Developmental Center, Fairview Developmental Center, and Porterville Developmental Center (part of which will remain open for forensic clients) will all close by 2021. The Governor is setting aside \$146M for this effort for this effort. It includes \$78M for Sonoma Developmental Center, \$29M for Fairview Developmental Center, and \$24M for Porterville. It also includes \$18M to resolve open workers' compensation claims through the Department.
- ✓ Since 2013/14 regional center costs have grown from \$2.5B to \$3.1B. This represents a 24-percent increase despite a freeze on provider rates.
- Caseload growth over the same period of time has only been 5.7 percent. The Department is working with the Regional Centers to figure out the cost drivers. Increases in autism services, an aging population, individuals transitioning from the developmental centers into the community, and individuals moving from their family homes into supported living arrangements, are all contributing to the increase.
- ✓ Many rates have been frozen for years, although rates have been increased recently for state and federal mandates such as minimum wage increases and overtime.
- ✓ The core staffing formula used to adjust regional center budgets based on the number of consumers served has not been adjusted for the majority of classifications since 1991.
- Under the Home and Community-Based Services Waiver, the federal government is mandating many changes to the delivery of services in the community. In recognition of these demands, the Budget includes \$80M for the following targeted investments in the developmental services system:
  - Establish four-bed Alternative Residential Model homes rate (\$46M set aside). The rates for these homes are old and were originally based on a six-bed model, so providers have two fewer beds from which to derive revenue while maintaining the same overhead. The smaller four-bed model is increasingly used by regional centers. A large portion of regional center clients living outside their family home live in Alternative Residential Model homes.
  - ➤ Case Managers (\$17M set aside for caseloads). The Federal government mandates a maximum caseload for each case manager employed by a regional center. That is approximately 200 additional caseworkers statewide when 600 are needed.
  - Compliance with Home and Community-Based Services Waiver requirements (\$15M set aside). The Department will target rate increases to providers to transition services like segregated day programs and sheltered workshops to models that are more integrated in the community and consistent with the Home and Community-Based Services Waiver.
- ✓ The Administration will also continue its work with the developmental services community to develop data-driven solutions to the issues facing regional centers and providers. Any additional targeted spending proposals are expected to be funded from the proposed extension of the managed care organization tax.
- ✓ There is a projected \$300M surplus funds that may be available statewide that will deal with MediCal rates issues.

### Michi Gates, Director, Client Services, Report:

- Consumer Advocate, Randy Kitch, noted in his report (page 13) that voter registration for clients is up in both NBRC's Napa and Santa Rosa offices.
- NBRC has two new vendors, one of which is a Behavioral Services Agency as well as a UCP Senior Day Program in Rohnert Park.
- DDS is working with the California Department of Education to improve the quality of training for Direct Service Professionals in licensed residences across the state. The training is now more comprehensive and uniform. The trainings will occur at the Napa NBRC office.

- Rate adjustments have been made for vendors relative to the Fair Labors Standard Act that changes
  rules regarding over time and minimum wage increase. Michi thanked Courtney and her team and
  the Fiscal Department for processing the 5.8% increase and distributing payment to providers.
- NBRC is in the process of completing Request for Proposal (RFP) interviews for Resource Development for the Sonoma Developmental Center closure. Michi thanked Pat Walters for attending the interviews representing family members at SDC. Michi thanked Courtney and her team and Tara Knudson and her Resource Developers on a job well done.
- SDC: Parent Hospital Association (PHA) meeting was held in January. A topic of real concern noted by family members is a lack of a true state staff program with the closure of SDC. When Agnews Developmental Center closed, the State workers were able to retain their salary and benefits but work in the community with providers as clients transitioned. This program has not been replicated since then.
- Monthly parent meeting at SDC regarding closure with the focus on health services. Alisha Gutierrez
  was present to address issues surrounding dental services. Dr. Stephan Betts provided a presentation
  regarding the proposal to develop a federally qualified health clinic in the Santa Rosa area.
- NBRC continues to work on the behavior health services transition to Partnership Healthcare Services.
   There will be no gap in services during the transition.
- In addition to hiring new Service Coordinators and Resource Developers, NBRC has also hired an Intake Physician. She is not licensed in California and is in the process of becoming licensed. Once she obtains her license, she will begin.
- Jake Stebner, Attorney at Law, is NBRC's new Legal Specialist effective February 1, 2016.
- Deanna Kirkpatrick, Intake Department Manager, provided a brief overview of NBRC Intakes/data for 2015.
  - ✓ In 2015 the Intake Department received 424 intake referrals compared to 377 in 2014, which is a 12.5% increase. This included applicants over three sent to NBRC by doctors, schools, the court system, and friends and families in the community.
  - ✓ NBRC averages approximately 80 plus Intake calls per week.
  - ✓ This year a new Intake Referral Coordinator position was added so turnaround callbacks are down to two days.
  - ✓ 2015 Intake Team met 100% of the timelines (also met in 2014).
  - ✓ There were 62 intakes for the month of October 2015 alone. Never know which months are going to be busier.
  - ✓ In 2014, 53% of intakes qualified under Intellectual Disabilities compared to 42% for 2015.
  - ✓ Autism intakes were 42% in 2014 and 47% for 2015. We have clients who qualify for services with more than one diagnosis.
  - ✓ There were 16 appeals on eligibility submitted in 2014 compared to 15 in 2015. Most appeals
    were withdrawn with a few going to Fair Hearing. Kudos to Dr. Todd Payne and attorney Jack
    Benge for handling these appeals. If a Claimant requests an "Informal Meeting", oftentimes Todd
    is able to explain the process/criteria and how NBRC came to a decision of determining Claimant
    ineligible for services, thereby withdrawing their request for hearing.
  - ✓ Bob noted that we are showing 50% in Intake for autism yet only 22% of total population have a diagnosis of autism. There are two categories that a person has to qualify for eligibility. The first is having a qualifying condition, i.e., Autism, Epilepsy, Cerebral Palsy, and 5<sup>th</sup> category. Second a person has to meet three out of seven conditions (five conditions for children and seven for adults).
  - ✓ Lisa Hooks, SCDD noted that the majority of the parents don't understand what qualifying conditions consist of. Discussion followed.

 Pamela Madden Krall, Training Coordinator, conducts NBRC orientations every month. Michi suggested Lisa connect with Pamela regarding some of these issues and resources available to families.

### Dave Johnson, Chief Financial Officer, Report:

- NBRC received the draft results for the independent audit. It was "clean" with no material discrepancies.
- Dave expressed gratitude and warm regards to Harry for his financial expertise and guidance and that it was a pleasure to have worked with him.
- Dave congratulated Bob Hamilton on ten great years at NBRC.
- At the most recent Chief Operating Officer Statewide meeting, there was a lot of focus on Purchase
  of Service and why the Regional Center doesn't understand it. The Federal government is very mindful
  of what the State Department of Finance is spending money on. The Developmental Centers are
  required to reimburse the Feds for overbilling \$54M. The Department of Finance is now auditing the
  Department.
- No audited financials of any regional center are identical. The Department of Finance is trying to gather data to compare but no data is the same.
- The rate freeze is causing a lot of problems because we can't get new vendors etc.

#### LIAISON REPORTS

### A. Association of Regional Center Agencies (ARCA) – Bob Hamilton (10 minutes):

- ARCA met in Sacramento on January 21 & 22 at ACRC. The Department was in attendance via conference call. The Department told Regional Centers to locate vendors who have programs that need help so they can frame it into a rate increase. It isn't always about the rate but about the eroded capital structure. "A Long Road out of Eden" as the Eagles say.
- DDS is hiring more auditors so that they can audit vendors. They are also creating another
  program consisting of ten people that will establish aggregation of numbers across the system.
- DDS will provide Regional Center system funding to contract compliance positions to work with provider community to see how they are doing with the new CMS rules.
- Harry not only carries a heavy load as the President, he has served as the ARCA Representative. Bob expressed gratitude to Harry for understanding what is going on in the system and keeping abreast of all the issues. The ARCA Board is comprised of a Board member from each Regional Center and its Executive Director. There are 21 Board members and 21 Executive Directors that attend this meeting. The group votes on system-wide issues and are asked to testify at legislative hearings and meet with legislators who need assistance. The Board has a delegates meeting Thursday evening and then meets from 8:00 a.m. to Noon on Friday morning for the ARCA Board meeting.
- Franklin Phillips volunteered to attend ARCA on March 17<sup>th</sup>.

### B. State Council on Developmental Disabilities/North Bay Regional Office - Lisa Hooks - (10 minutes):

- SCDD was audited and because they receive federal funding, the auditor told them they should
  not be providing certain services. The focus should/will be totally systemic. SCDD will continue
  to receive complaints on behalf of clients but direct people to the local regional center followed
  up by an email to the Service Coordinator and Supervisor and/or Office of Clients Rights.
- Lisa will be working with NBRC on disparity data issues, community meetings, and the best way to outreach to parents.
- Lisa will also be working with staff involved in Self Determination.
- Lisa is the lead on the Early Start for the State Council for the five-year SCDD State Plan. One
  of her goals is how to obtain Early Start referrals and disseminate materials regarding Early Start
  issues.
- Emergency Preparedness registry. Lisa is working with emergency sites with local communities

to assure they have medications stored for our target population.

- Public safety regarding law enforcement issues. SCDD conducts a statewide training of police cadets on how to better understand people with developmental disabilities.
- Grants to provide training to law enforcement agencies.
- UC Davis MIND Institute is holding a meeting on alternatives to conservatorships. Lisa
  encouraged everyone in attendance to let SDC families know. Date and location to be
  announced.
- Military families Lisa requested an opportunity to work with Service Coordinators who have military families on their caseload to assure a continuum of services when they move.
- SCDD is in the process of redesigning their webpage to include generic resources for all counties.
   This will increase seamless services and allow families to transition and successfully navigate their way through the system.
- SCDD is in the process of offering grants for next year's cycle. SCDD is requesting each regional
  area offer two service ideas that are important and needed for individual areas. SCDD would like
  to provide grants for training or services on these topics. Grant application is on the SCDD
  website.

### Federal Revenue Department Board Report for Quarter 3, January-February-March, 2016

- Goals: Our semi-annual target for the 15/16 fiscal year is to have an enrollment total of 3758 individuals into the Medicaid Waiver program by 3/31/16. These targets have been established by DDS along with the requirement to add clients to the waiver monthly. Missing our target or not adding monthly can result in the withholding of federal funds in our operations budget and less POS (purchase of service) reimbursement.
- **Status**: As of 1/31/16, NBRC has 3737 individuals enrolled in the Medicaid Waiver program, with an additional 21 individuals to add by 3/31/16. This represents 52.2% of all active clients eligible for Federal Financial Participation (FFP).

### • Audits:

### **HCBS** Audit

California's Department of Developmental Services (DDS) and Department of Health Care Services (DHCS) completed a Medicaid Waiver audit May 11<sup>th</sup> - 22<sup>nd</sup> at NBRC. Preliminary findings from this Medicaid Waiver audit were minimal and considered positive. NBRC still has not been presented the official audit findings from DDS.

- **Training:** Department Manager and Federal Revenue staff provided New Employee and unit trainings for Service Coordinators in the months of January and February, and scheduled for March that reviewed:
  - o An overview of General Audit Checklist requirements
  - o The Federal Definition of Case Management
  - o Title 19/Targeted Case Management (TCM) notes
  - o Completion of the Annual IPP Review form, as required per regulation
  - o Client Development and Evolution Reports (CDER) requirements and instructions
  - o Time Study instructions and requirements

### DDS/NBRC updates:

### 1915 (i) SPA

NBRC has volunteered to be one of the first Centers to pilot the implementation of managing the 1915(i) SPA (State Plan Amendment) beginning March 1<sup>st</sup>. NBRC will be receiving the SANDIS system upgrade as well as the list of clients that DDS has determined are eligible for this federal reimbursement.

The 1915(i) SPA was submitted by DDS in 2008 and has been approved by Centers for Medicaid Services (CMS). The state has been enrolling eligible clients since the formal approval in 2014. The 1915(i) SPA will allow California to receive federal funding for POS services for individuals who may not qualify for Medicaid Waiver, but will not provide funds for operational expenditures for Centers at this time. The additional workload of verifying eligibility will be absorbed by the current Federal Revenue staff

(2.5 FTEs). Service Coordinators will be required to conduct annual IPP reviews and update CDERs, just as they do for the Medicaid Waiver program.

### **Self Determination Program**

The NBRC Self Determination Advisory Committee met on February 25 at North Bay Regional Center (NBRC), 25 Executive Court, Napa. For this meeting, Committee members proposed the following Agenda Items:

- o Election of a Chairperson
- o Update on the Self Determination Program
- o Discussion of Emerging Issues
- o Update of DDS created trainings for participants

### **Nursing Home Reform**

DDS will be attempting to capture additional FFP by requesting discharging LTC facilities request Pre Admission Screening and Resident Reviews (PASRRs) to be conducted by Centers, not just upon admission. The additional workload of processing these Level II PASRRs will be absorbed by the Federal Revenue unit.

### Money Follow the Person Demonstration Grant


Currently, 35 clients are being tracked for eligibility for the MFP Grant federal reimbursement, with more anticipated as a result of the closure of Sonoma Developmental Center. The MFP Enhanced federal monies (75% reimbursement on qualifying purchases; no Operations match) are available for those individuals transitioning from an institution to the community. Regional Centers are required to enroll all eligible and willing consumers in MFP if they transition from any licensed health care facility defined as an institution (e.g., developmental center, SNF, ICF) to a 4-bed or less community living arrangement (including the consumer's family home, community care facility, or a supported living arrangement).


