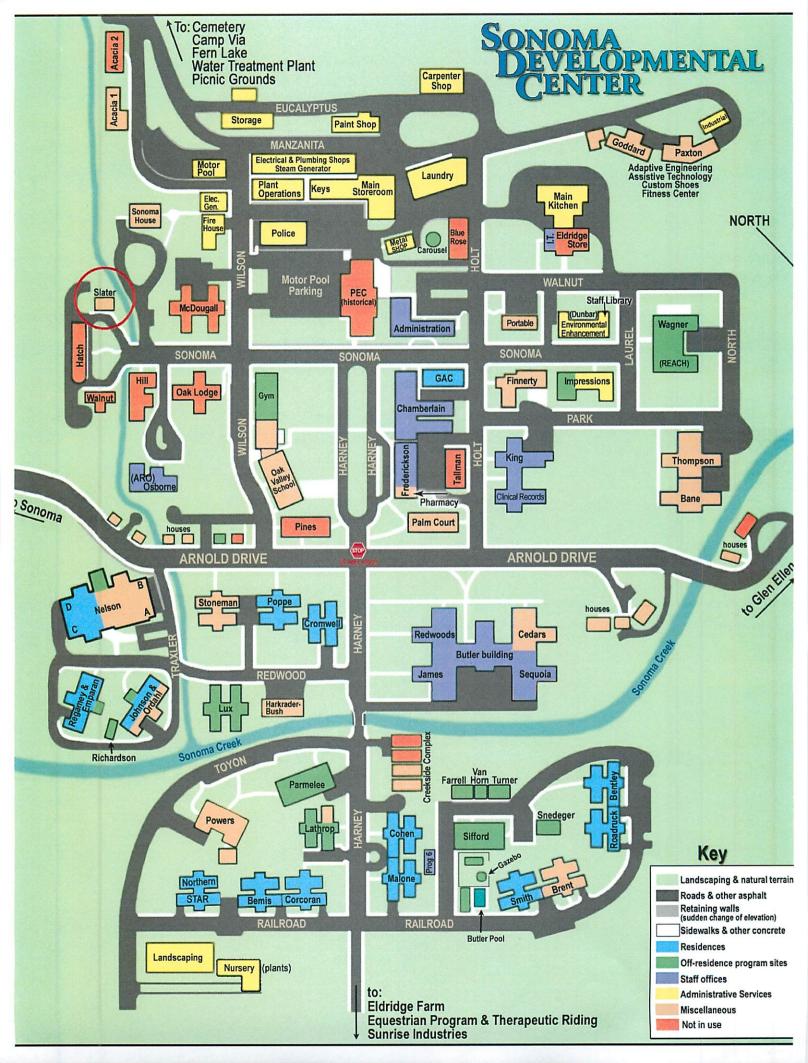

FEATURE PRESENTATION: Performance Contract – January Crane, Federal Revenue Department

Manager

North Bay Regional Center promotes opportunities and supports choices for people with developmental disabilities in Solano, Sonoma, and Napa Counties. The Performance Plan for 2018 reflects targeted activities NBRC will engage in to improve outcomes related to local and public policy measures as a result of both internal review and external feedback sessions.

January noted that one of her responsibilities to the agency is reviewing NBRC's performance contract and performance plan and providing recommendations and gathering information from DDS and local partners and well as internal information. This is done every year by all Regional Centers who have basic public

policy measures that are tracked throughout the year. Each regional center has some discretion on choosing local measures.

- Fewer clients reside in state developmental centers NBRC will reduce the number of individuals living in DCs; increased staffing for resource development and service coordination of DC clients will result in more individuals being transitioned to community living options
- More children live with families (including own family, foster family, and/or guardian NBRC continues monitoring family and children's support needs around health, living arrangements, school and leisure goals.
- Fewer children live in licensed homes serving more than six children NBRC will continue
  developing alternative living arrangements that meet children's support needs in the least restrictive
  setting. NBRC will continue utilizing the Living Arrangements Committee to identify living
  arrangements that meet both support needs and choice in the least restrictive manner.
- More adults live in home settings (includes living with family, parent or conservator, adult family home agency – FHA, independent living, or supported living arrangements) - NBRC continues advocating for individuals to assert their rights to access the living arrangement of their choice, and NBRC is committed to developing a wide array of options including family support for adults choosing to live in the family home.
- More adults reside in independent living arrangements NBRC continues working with clients and families to identify appropriate living arrangements, including development of ILS services.
- More adults reside in supported living arrangements NBRC will continue identifying supported living options and advocating for affordable housing options.
- More adults reside in family home agency (FHA) NBRC will continue identifying FHA as a living
  option, working with vendors to ensure quality services and supports that meet individuals' needs
- Fewer adults live in licensed homes serving more than six adults NBRC develops homes that serve four adults or less while meeting health and behavioral needs and meeting anticipated CMS settings rules.
- Number and percent of adults (ages 16-64) with earned income NBRC will continue working with the Dept. of Rehabilitation and local collaborative groups (e.g., Mayors' Committees, Community Advisory Committees) to promote Work First with the individual planning team and increase employment opportunities.

- Intake/assessment and individual family service plans are completed in a timely manner NBRC will continue monitoring IFSP input data internally to ensure IFSP's are completed in a timely manner.
- Client Development Evaluation Reports (CDERs) and Early Start Reports (ESRs) are current -NBRC will continue monitoring monthly reports to ensure CDERS and ESRs are current; internal quality monitoring and monthly auditing will identify reporting errors and missed dates to increase reporting compliance.
- NBRC operates within OPS budget NBRC will continue to monitor through monthly reporting.

- Provision of information to consumers regarding Employment First Policy, opportunities for employment and available supports to achieve integrated competitive employment - NBRC will be instructed and supported on providing information to their clients and families during the IPP process specifically re: Employment First and the necessity of discussions around employment options. NBRC will promote Work First with the individual planning team and provide training to Service Coordinators on advocating for integrated employment preparation and opportunities in the community.
- Number and percent of individuals, by ethnicity, who are satisfied with the services and supports received by the family and family member - Current NCI data identifies that per survey:

NBRC will use data related to satisfaction to identify and develop targeted resource and support needs in the community.

Update on Community Placement Plan Contract Awards - Courtney Singleton

#### **COMMITTEE REPORTS:**

- A. <u>Executive Committee</u> Harry Matthews, President; Angel Giroux-Greber, Vice President; Rita Edmonds-Norris, Secretary; Franklin Phillips, Treasurer No meeting.
- B. Vendor Advisory Committee Linda Plourde
  - The VAC met on Tuesday, August 8, 2017.
  - Members of the VAC continue to discuss ways to increase Residential Service Provider participation in the Vendor Advisory Committee Meetings and other informational/collaborative sessions. David Mauger, Residential Services Provider and VAC Member, has taken an important lead on ensuring that the NBRC Vendor Community benefit from the participation of those who provide residential support for people with I/DD. He will work with Isabel Calder, NBRC, to notify residential service providers of opportunities to become more involved with the vendor community. The Vendor Relations Committee comprised of the voting members of the VAC and Dr. Gates, NBRC, will further address this topic at its next meeting.
  - The vendor community is collaborating to bring nationally acclaimed speakers to our area for direct support professional training. The first of the trainings is scheduled for September 27, 2017. Diana Pastora Carson will present on her brother's journey from a state developmental center to community living. A future training will be by Joe McBeth and John Rafaelle, National Alliance of Direct Support Professionals, on supporting our employees as they work with our clients each and every day.
  - The vendor group discussed that referrals for SLS are at a minimum. The internal NBRC process
    was discussed. January Crane and Thomas Maseda will discuss with QA and the Executive Team
    respectively to ensure that referrals are not slowed down due to potential issues with the internal
    process.
  - The vote for Assembly Bill 279 (Holden) is set for the end of August. The bill did not pass. This bill addresses reimbursement for minimum wage increases at varying levels throughout the state. Some locales are implementing a minimum wage that is higher than the state wage.
  - The Repeal and Replace of the ACA did not succeed. Currently a bipartisan group of 43 senators
    are working to come up with improvements to the ACA. It is possible that per capita caps and
    block grants will make a comeback once Congress returns to work after August recess.
  - Please refer to the minutes for further detail. The next VAC meeting is Tuesday, September 12, 2017.

### **EXECUTIVE DIRECTOR'S REPORT**

Bob Hamilton, Executive Director

- Governor Jerry Brown, legislators, and leaders will protect Californians under the Deferred Action for Childhood Arrivals (DACA). In this environment with this regressive government, it magnifies the fear of deportation.
- Bob noted that he is looking forward to the SDC closure so all people NBRC serves will have the
  opportunity live in the community. Bob noted that the Director of the Department has agreed to move
  money into community resource development enabling NBRC to use the funding for those moving out
  of SDC. NBRC will also be able to use the funding to develop resources for those who need to move
  to a different level of care. The new model (enhanced behavioral support home) provides a rate
  structure that supports each individual.
- Adult Residential Facilities for Persons with Special Health Care Needs (ARFPSHN) were first
  developed during the closure of Agnews Developmental Center. ARFPSHN is a refined model and
  clients receive excellent care. NBRC is looking for the same level of expertise in the development of

homes for clients with behavioral needs who have suffered greatly due to the lack of resources in the last several years.

- The Department is working on the November estimate which is used to develop the Governor's Budget due January 2018. The budget subsequently gets revised by the legislature followed by the May Revise and then voted on in June.
- Continuation of funding for ABX2 which requires all vendors to complete a rate survey. Only 40% of NBRC vendors have completed the survey. If vendors don't complete the survey, they won't receive the increased rate. 100% participation is required. NBRC will provide training to assist vendors.
- NBRC is back on the waiting list for self-determination services. The Feds have more questions and are sorting through them.
- NBRC received the D1 allocation which tells us how much money we will receive in Operations.

Michi Gates, Associate Executive Director, Client Services' Report – Attending Chief Counselor's Meeting No report

### Dave Johnson - Chief Financial Officer

- Purchase of Service expenditures is up by 16% from last year. Community Care Facilities costs are
  increasing. NBRC is in the process of constructing 30 plus homes for residents moving from SDC into
  the community. These homes are much more expensive than a normal group home. Historically NBRC
  provided "start-up" funds for 4l homes. That is no longer the case.
- Community Placement Plan (CPP) expenditures for last fiscal year was \$715K and this fiscal year expenditures were \$5M to date. The growth in POS statewide is huge.
- Operations grew by 14% this fiscal year due to the ABX money that increased staff wages by at least 10%. Sixty percent of NBRC staff also received a 5% merit increase.
- NBRC reduced cost for facilities and equipment substantially.
- There was a grand total of \$524.00 left in Operations at the end of the fiscal year.
- Fiscal year 2005/2006 there were no behavioral services for children who needed them. Behavioral serves 07-09 increased from 0 to \$15M. Every year since then NBRC has been able to build on and refine that number.
- Harry commended Dave and Thomas for saving money by moving NBRC, i.e., the agency is saving \$300K per year in rent.
- In Operations \$.86 of every dollar is spent on employees' wages and benefits. NBRC has put money where it needs to be to ensure the needs of our clients.
- Thomas noted that the contract between the Union & NBRC Management expired February 2017.
   There are tentative agreements on language of the contract. NBRC and SEIU have made a number of proposals on the monetary side of the agreement. Moving forward and hope to finalize a contract/agreement soon.

### **LIAISON REPORTS:**

- A. Association of Regional Center Agencies Bob Hamilton
  - ARCA is continuing with Person Centered Training across the state. This goes hand in hand with assisting with disparity and self-determination. In conjunction with the rate study, this will mold the system for the next few years.
- B. State Council on Developmental Disabilities North Bay Regional Office Lisa Hooks
  - California Disability Services Institute is hosting Fostering Art & Microenterprise (FAME) scheduled for September 28<sup>th</sup>. This is a showcase of art and microenterprise by individuals with developmental disabilities.
  - The California Public Utilities Commission (CPUC) has launched an 18-month pilot speech technology program called Voice Options, which will offer iPads with speech applications to people with speech disabilities for short and long-term loan through 10 demonstration centers throughout the state. The pilot program is associated with the passage of Assembly Bill 136 (Beall, 2011). It

- is administered by the California Foundation for Independent Living Centers and funded through the CPUC's Deaf and Disabled Telecommunications program. The CPUC is currently taking applications for IPad speech program.
- The 2016 California Voter Choice Act is bringing important voting changes to Napa County on June 5, 2018 including every voter receiving a ballot by mail and new vote centers and drop box locations throughout the county for returning a vote by mail ballot. Napa County is seeking input on a draft Napa County Election Administration Plan which will guide outreach efforts. Voters with Disabilities (VAAC) will meet September 6 from 3:30 to 5:00 p.m. at Napa County Election Division.
- Healthy Minds & Healthy Aging is hosting Alzheimer's and Dementia Caregiver Workshops to caregivers who have loved ones with moderate to advanced Alzheimer's or related dementia. This is a free community event. "Learning to Speak Alzheimer's Part 1" is being offered on September 27, and Part II on October 25<sup>th</sup> at Collaborative Care, 404 South Jefferson St., Napa. Noon to 2:00 with lunch provided.
- Sonoma County families are requesting waivers for immunizations. California has conducted a survey which clearly indicates that there has to be a legitimate reason for requesting a waiver. Families who oppose mandated immunization for school children may be seeking medical exemptions to get around the new state law, which requires kindergartners entering public and private schools be fully vaccinated regardless of families' personal beliefs, according to a study published in the Journal of the American Medical Association. The increase in medical waivers suggests that anti-vaccine parents may be finding doctors willing to exempt their kids from the mandate. Many of the California counties with the biggest increases in medical exemptions since the law took effect are in Northern California, i.e., Sonoma. Many parents who don't want vaccinations for their children, including some vocal opponents from affluent, well-educated regions of the state, say they are concerned that vaccines are linked to autism, overwhelming scientific evidence to the contrary.
- Disability Services & Legal Center presents the 12<sup>th</sup> Annual Tech Expo on Friday October 13 from 10:00 a.m. to 3:00 p.m. There will be 100 plus exhibitors of products and services. This event will be held at the Grace Pavilion at Sonoma County Fairgrounds in Santa Rosa.
- California Child Abuse and Neglect Reporting Law requires three additional groups of people be identified as mandated reporters, i.e., athletic coaches, foster family agencies, and foster family homes.
- The current Denti-Cal Contract requires Treatment Authorization Requests (TARs) be processed on an average of 15 calendar days. Pursuant to W&I Code Section 14133.9, the TAR turnaround time is being reduced from an average of 15 days to an average of 5 working days. The Denti-Cal program is dedicated to improving beneficiary utilization and helping providers decrease the number of patients who fail to or cancel appointments. When patients do not attend scheduled appointments, dental offices suffer as they have reduced capacity to schedule other patients and may potentially lose revenue from missed appointments and increased overhead costs.
- California funds non-profits to serve food as medicine and delivers food to adults with disabilities. The three-year pilot program, which begins in January, was included in the recently adopted 2017-18 state budget. The program will debut at hospitals, doctors' offices and clinics in parts of Sonoma County. This will enable doctors to give their patients prepared meals before they return home. One of the non-profits will follow up later to schedule regular food deliveries. The means will be custom-made for each patient's medical condition. Details of the project, including the specific hospitals and clinics where food will be available, are "still in the planning stages".
- California hits Kaiser with \$2.2 M fine for failing to provide required Medicaid data. Kaiser has said
  its systems and technology are not designed to collect information in the format required by the
  state.
- Sonoma Clean Power, the not-for-profit public electricity provider for Sonoma and Mendocino counties, is bringing the cost of electric vehicles down to clearance-sale levels. The second year of the agency's Drive EverGreen electric vehicle incentive program offers deals on mine models sold

and leased by seven local dealers. For information on Drive EverGreen, go to sonomacleanpower.org for information.

- Computers for Classrooms, a non-profit computer refurbisher, provides classroom services if recipients participate in the following:
  - ✓ Medi-Cal, CMSP, Healthy Families, Food Stamp Card, Section 8 Housing, have a child in school receiving free or reduced price lunch, AT&T lifeline, PG&E Star program, Energy Assistance Program Rate, Butte Community College student, Fire victim with Red Cross assistance letter, Veteran with Veteran's Administration card, Social Security Disability, Senior aged 65 or older.

# Vendor Advisory Committee Report to the NBDDS Board of Directors October 4, 2017

The VAC met on Tuesday, September 12, 2017.

The vendor community is collaborating to bring nationally acclaimed speakers to our area for direct support professional training. The first of the trainings is scheduled for September 27, 2017. Diana Pastora Carson will present on her brother's journey from a state developmental center to community living. Fifteen agencies committed to paying \$200 to cover the costs of the training and to send employees. The training will be held at the Napa Elk's Lodge: two sessions 9 a.m. to noon and 1 p.m. to 4 p.m.

The Repeal and Replace of the ACA is on the table once again, this time in the form of the Graham/Cassidy bill. The bipartisan effort that I mentioned in the September report did not gain traction and is no longer an option. Some Republican Senators are stating that they will not vote for the bill in its current form. Some states are offered more money as a way to get the Senators to vote in the affirmative, i.e. Murkowski for Alaska, Collins for Maine, Arizona for McCain. The push is to attempt the Repeal and Replace before the end of September as they only need 50 votes to pass it. After September 30, the GOP will need 60 votes to pass the healthcare bill.

The VAC is accepting applications for its vacant seat. The VAC intends to select a new member by the October meeting. ,
