




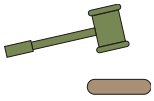

- Jim Knight – DDS- announced that the waiver application was submitted by DHCS on February 13, 2018.



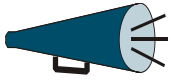
### How Do We Make it Work

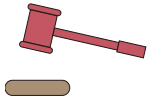
