VII. Review and Discussion of outstanding Board Policies

a. Central Role of Parents (No. 3)

- The purpose of the policy is to empower clients, respect and honor their choices using a person-centered approach, honor their circle of support including families and selfadvocates.
- Geri Audette, Training & Communications Specialist, will draft initial concepts for the policy using a person-centered language.
- The Committee agreed to have a policy to highlight the family's involvement in the client's decision-making and perhaps beyond disability support.
- Martha Valdez, Board Member, added that in addition to supporting the person with disability, we should aim to support the families too.
- Derek Hearthtower, Community Member, emphasized that the clients should be able to choose their own family support.
- The Committee identified the need to review and revise this policy.
- The Committee will continue discussions in the next meeting.

b. Accessibility of Facilities Policy (No. 14)

- Anaid Carreno, Diversity and Equity Specialist will take the lead in finding a language about true accessibility and inclusivity for this policy. She will provide an update in the next meeting.
- Sara Speck, Board Vice President, suggested sharing this policy with the Client Advisory Committee for their input.

c. Integrated Programs Policy (No. 16)

- Gabriel Rogin, Executive Director, proposed a policy statement to promote independence and integrated settings.
