Self Determination Program

North Bay Regional Center

What is Self Determination?

- The Self-Determination Program (SDP) provides individuals and their families with an alternative to the traditional way the regional center provides services. This person-centered program affords participants with more authority over their service needs and preferences. Participants are empowered to select which providers deliver the services they feel will best support their individual goals, while owning the responsibility of overseeing the dollars allocated by the regional center for their use. Now, regional center clients have the freedom to decide what they want their life to look like and create a plan to make it happen.
- Our five principals are:
 - 1. <u>Freedom</u>: to plan their own life and make their own decisions.
 - 2. <u>Authority</u>: to determine how funding is spent for their services and supports.
 - 3. <u>Support</u>: to plan and choose their own formal and informal services.
 - 4. Responsibility: for the decisions they make about their life.
 - 5. Confirmation: of the critical role in making decisions in their life.

SDP vs. Traditional Services

- Self-Determination provides the flexibility for the participant in choosing services, supports and providers. In the Self-Determination Program, they can buy different services from almost anyone in their community, not just those available through the regional center.
- In the traditional program, the regional center service coordinator is the person who helps participants find the services they need. In Self-Determination, participants get to decide who they want to help them. This can be their family, friends, or an Independent Facilitator. Participants will be given a budget and then create a spending plan that will enable them to choose services and supports that help them achieve their goals.






SDP Enrollment




SDP Enrollments by Ethnicity




SDP Enrollments by First Language




SDP Enrollments by Age and Gender

Self Determination Advisory Committee (SDAC)

- As required by law, each regional center must establish a Local Volunteer Advisory Committee to ensure effective implementation of the Self-Determination Program and facilitate the sharing of best practices and training materials. The committee provides oversight of the Self-Determination Program and to give consumers and families a voice in the development and implementation of SDP.
- North Bay Regional Center's SDAC meets on the second Monday of the month, every two months. Our next meeting is May 8th, 2023 at 12:30pm to 2pm via zoom.

Barriers and the Necessary Next Steps

- FMS waitlists
 - DDS is working to help minimize the waitlist times for SDP participants enrolling into SDP.
- Staff Training
 - The SDP Team is working on developing an all-staff training for SDP.
- Independent Facilitators in the North Bay area
 - We are working on recruiting independent facilitators in our counties!
- Streamlining processes to enrollment into SDP
 - The SDP Team is developing an enrollment procedure, list of common acronyms, and a flow chart for staff to utilize.
- Outreach about SDP
 - The SDP Team is working on SDP fairs for each county and spreading the word about SDP so all participants can take advantage of this program!

Successes in SDP

- Since the department forming in September 2023, we have increased enrollment from 14 to 28 participants.
- The creation of a fully staffed SDP department has allowed stress to be taken off the Service Coordinators when enrolling interested clients into SDP.
- Clients are reporting feeling more supported in the enrollment process since the creation of the department.

AB 649 (Wilson) – SUPPORT

Honorable Assemblymember Wilson:

North Bay Regional Center (NBRC) is a non-profit, community-based organization established to support individuals with developmental disabilities, and their families, and ensure that they have the opportunity to lead independent, productive lives in their home communities. NBRC serves over 10,000 people within Napa, Solano and Sonoma Counties.

We support AB 649, your bill to remove a Recession-era barrier to regional center services. North Bay Regional Center cares deeply about ensuring all Californians eligible for regional center services can access what they need to live full lives in their communities. The requirement this bill would remove is a barrier to access.

Regional centers are legally the "payer of last resort," both by state law and federal mandate. During the Recession, the state created a new barrier to service, requiring that people not only seek, and be denied, services from another agency (where appropriate), but to appeal that denial in many cases. This purely bureaucratic hurdle is the kind of thing that is most likely to disempower people from low-income and diverse communities. It worsens disparities in access, and harms those families who need the most assistance in accessing regional center services.

We strongly support AB 649. All eligible Californians should be able to access regional center services, which is why barriers like this should be removed. We thank you for authoring this bill, and fighting to improve service access for people with developmental disabilities.

AB 649 – Restoration of Access to Disability Services

BACKGROUND

When the Great Recession struck, California took major steps to address the sudden and massive short- and long-term revenue effects it caused. The regional center system, a community-based model of people with developmental for disabilities, saw roughly a billion dollars in funding cuts. A number of the cuts were made at the expense of access to services, disproportionately falling on diverse and low-income communities with limited recourse to other options.

To restore our service system's ability to most effectively meet changing needs in a changing state, requirements that families try to navigate bureaucratic obstacles before accessing critical services must be reversed. This bill provides a simple opportunity to do so by reversing an access-limiting change from 2009.

SUMMARY

Restore access to critical services without first pursuing administrative appeals: Based on individual needs, the person served, family members, and a regional center service coordinator work together to create an "Individual Program Plan" (IPP). The IPP ensures only those services appropriate to an individual's needs and circumstances are purchased (with state and federal funds). Regional centers work to connect individuals and families to all programs they are eligible for.

Consistent with federal funding requirements, regional centers are the "payer of last resort" for services. This means before funding needed services, regional centers must identify other options (if any) to pay for them. ABX4-9 (Evans, Statutes of 2009, Ch. 9) created an additional

requirement blocking regional centers from buying services unless, in many cases, the individual or their family member goes through a formal appeal at the other funding agency (such as Medi-Cal) after being denied funding. By forcing the administrative appeal mandate on those served and their families, an unnecessary hurdle is created.

For those families who rely on the greatest number of safety net programs, the burden is greatest. Those who are better able to navigate bureaucratic systems are more likely to succeed. They are the families with the greatest resources (time, knowledge of bureaucracy, etc.). Meanwhile, historically under-served communities, become significantly less likely to ultimately obtain services they are entitled to, in part because they are not able to jump through these hoops. By reversing this mandate, California can invest in more equitable access to reducing barriers services, that disproportionately under-served harm communities.

Summary

EN is a 36-year-old un-conserved female who qualifies for Regional Center services with a diagnosis of Autism. EN's SSI benefits have been terminated due to Social Security determining she earned too much money from her current job as a teacher's aide. EN's representative payee is New Leaf. She submitted her pay stubs to New Leaf, as required, when she began her job in November 2021. However, Social Security was delayed in reconciling their records and sent notification that benefits would stop effective March 2023. With New Leaf's help, EN was provided an attorney to assist with getting benefits reinstated and they have filed an exemption request that will allow for her benefits to resume for 6 months while she makes application to SSA for eligibility. Although EN works part time and makes approximately \$1000 a month, her hours are not consistent. She does not have enough funding to cover her rent for April and no other funding sources are available.

EN is requesting rental assistance for the month of April; the amount is \$1042.00. She had enough funds to cover her March rent. With the exemption filed, EN and the attorneys are optimistic that she will not need further financial assistance.

ARCA Academy

ISSUE: Information on the regional center board training event

FAIR HEARING & MEDIATION UPDATE MARCH 1, 2023 – MARCH 31, 2023
