a. NBRC Staff

An introductory webinar session is provided for staff to learn more about the training in addition to 6 online courses and one in-person session.

 - The attendance for "Trunk-or- Treat" event on October 31, 2023 was great with a good presence of families, clients, vendors and NBRC staff.
 - We hosted the English and Spanish Focus Group meetings in the month of October, and we received great feedback.
 - We have completed six NBRC presentations in Spanish to spread the word about our services within the month of October with the Neighborhood Initiative, which is a community-based organization in Napa.
 - We did a presentation to a community-based organization in Napa that focuses on violence and domestic violence.
 - We will be updating our 2024 Focus Groups meetings to include the educational workshops.
 - The next Focus Group meeting will be held on 01/17/2024 in person in Santa Rosa in Spanish, English and Tagalog. We will be holding a virtual session on 01/24/2024 at 10am and 3pm.
 - 2024 Focus Group meetings will be scheduled to take place on a quarterly basis starting February 13, 2024.
 - She will share with Rosemarie the contact details of the community-based organizations to explore potential interest in board membership.
 - She will follow up with Taylor Berry, VAC Representative, on any possibility of arranging Thanksgiving and Christmas events/gifts for clients.
