VII. CLC Updates

a. NBRC Staff

- Abigail Andrade, Community Outreach and Engagement Specialist provided an update on the first quarter's initiatives, highlighting the engagement of 449 individuals through meetings, outreach, and cultural events.
- Two cultural events were held as below:

 - Women's History Month
- Anaid Carreno, Diversity and Equity Specialist, provided an update on the Community conversations that were held on March 27 on POS authorizations, utilization, and expenditures related to clients' age, ethnicity, primary language, residence type, and diagnosis.

- Some suggestions for changes came up in regard to the approved Lanterman Act Policy and the Committee agreed not to make any further changes to the policy.
