CALL TO ORDER -

Angel Hixson, President called the meeting to order at 06:00 p.m. A guorum was present and the Board and audience introduced themselves.

CONSIDERATION OF MINUTES -

M/S/C (Edmonds-Norris/Phillips) Move that the minutes of the April 3, 2019 regular business meeting be approved as submitted. **UNANIMOUS**

GENERAL PUBLIC COMMENT -

Mitch Freese, a parent of a 37 year old NBRC client noted the following:

Within the last five years his son has experienced significant difficulties. He stated he was very thankful for his son's current Service Coordinator, Laurel Anderson. She was assigned to them after going through several caseworkers. She listened, did some investigating and has been the only person that has made it happen over the last 37 years. She advocated for the client and was able to get him into a new placement where he is doing well. Mr. Freese continued to give examples of the difficulties his family was faced with. He finished his public comment by saying Laurel is what it is all about and what you should expect in a service coordinator.

FEATURE PRESENTATION -

A. Diversity and Equity Update - January Crane, Federal Revenue Department Manager, Lindsay Franco, Diversity & Equity Specialist

Town Hall presentation to three separate groups, Napa, Vallejo and Santa Rosa.

Based on the presentations and the feedback collected they then brought it to the
 Disparity committee and created tasks for the Regional Center to follow up on.

Lindsay Franco, Diversity and Equity Specialist noted the following regarding NBRC's Feedback Action Plan for 2019:

- The categories of feedback are Services, Timely Communication, Education Outreach, Spanish Communication and Other.
- An Internal Docushare hub of information has been created
 - Any case manager can access it to find different resources available.
- ✓ Services;
 - We have the online sharing of resources that have already been vetted and could be printed and handed out.
 - Resources are sorted by need and continually updated.
- ✓ Timely Communication;
 - We have clarified agency expectations returning calls within a certain amount of time,
 - Social media is being used strategically to be able to share information faster with the community, any NBRC related news, policy or changes to legislature.
 - Everbridge notification system. It is able to send out messages in English, Spanish or any other targeted language. 600 messages were sent out for the Town Hall Meetings.
- ✓ Education and Outreach
 - Over 44 Outreach events over the last year.
- David Mauger asked "What would North Bay Regional Center identify as the top three needed services?"
- > January Crane replied and noted the following from the Town Hall Meetings feedback sessions:
 - Access to respite.
 - How to use respite and access to providers that speak their language and are culturally sensitive to the families.
 - Early intervention services
 - One pager on the different types of services. We want to empower the families to ask the questions.
- **B. Overview of Client Services –** Beth DeWitt, Director of Client Services noted her presentation would be a quick overview of Client Services and offered to come back if the Board requests it. (Please see attached PowerPoint)
 - Case Management is the core business of the regional center.
 - The other departments of the regional center support the work that case management does every day.
 - There are six major departments that help support our mission statement.
 - 1. Intake including the Clinical team
 - 2. CSA invisible group that make things happen
 - 3. Early Start
 - 4. Children's
 - 5. Adults
 - 6. COAST

An Associate Director of Client Services oversees the Intake, Early Start and Children/Transition age units.

- Intake and Eligibility
 - ❖ There are 2 Assessment Counselors for each office
 - ❖ An Intake Referral Coordinator
 - ❖ A Clinic Coordinator
 - CSA, Client Service Assistant.
 - NBRC has two medical doctors, three psychologists, and one nurse dedicated to the Intake department.
- Two Early Start Departments, one in Santa Rosa and one in Napa
 - ❖ There are 11 EISC's in Santa Rosa, 11 in Napa.

- ❖ Each has a dedicated CSA, Client Service Associate.
- ❖ Each has a "Warm line" to receive all Early Start referrals.
- ❖ There are four Children's Departments, two in Santa Rosa, two in Napa.
 - Each unit has up to 11 Service Coordinators.
 - ❖ Each unit has a CSA, Client Services Assistant
- ❖ There are five Adult units, two in Santa Rosa and three in Napa.
 - ❖ An Associate of Client Services oversees the Adult Units for NBRC.
 - ❖ Each unit has up to 12 Service Coordinators
 - ❖ Each unit has a CSA, Client Services Assistant
- COAST Community Options and Support Team
 - 5 Senior Service Coordinators
 - 3 in Santa Rosa and 2 in Napa
 - ❖ 3 Nurses and 2 BCBA's (Board Certified Behavior Analyst)
 - Courtney Singleton currently oversees the COAST unit and NBRC is on track to have that move under case management supervision.
- What to expect from an IPP,
 - Driven by individual request from the person, and circle of support. Needs to be focused on them.
 - o Right now we do the IPP every three years but we are piloting an annual IPP.

C. Doug Cleveland Board Opportunity Fund Procedure Update -

Beth DeWitt, Director of Client Services noted the following;

This procedure was brought to the board in the summer. It has been 9 months and staff are suggesting we revise it. The Board Opportunity Fund has a balance that is bigger than it was before. Now that we have more funding available do we have enough funding to open up the criteria for grants?

- The Board shared their concerns. Opening up the criteria may put us in a position to deplete our Fund.
- David Mauger suggested creating a threshold. If the Fund falls under a certain amount, we should slow down on the types of funds being approved.
- Angel Hixson gave examples of a few approved grants. Examples are cremation, support client's integrity even after death, housing, and deposits. Those are high needs. Angel suggested putting our priorities in writing.
- > Beth DeWitt noted staff will be tracking the kinds of requests we received so we can report on that and see where the money is going and if there is a pattern.
- ❖ It was decided that more thinking needs to be done by staff before bringing it back to the Board.

D. Courtney Singleton, Director of Community Services

b. 637 Waiver Public Comment

Courtney Singleton noted the following;

 There is an ongoing need for Speech Therapist, Physical Therapist, and Occupational Therapists. The law doesn't allow us to use assistants and we are asking DDS to let us use them through a 637 Waiver. This is a shortage that everyone is experiencing. There would be one main therapist and then the therapist assistants will work under their supervision.

TREASURER'S REPORT - Rosemarie Pérez, Treasurer

- NBRC's Doug Cleveland Board Opportunity Fund had a net decrease of \$4,877.00 due to a \$5,000 transfer to the checking account and two donations totaling \$113.00.
- The savings account balance at the end of March 2019 was \$67,199.78
- Earned bank interest for the money market account came to \$9.99
- There was four awards totaling \$2,139.34 for the month of March.
- The ending balance of the Doug Cleveland Board Opportunity Fund checking account was \$4881,43

B. C-6 Contract Amendment

NBRC has received the C-6 amendment and is presenting it to the Board for approval. The amendment includes a net total of \$114,517. The amendment is comprised of \$160,392 that was allocated for SDC start-up funding and \$45,875 of those funds have been deallocated.

C. Vendor Advisory Committee Update -

David Mauger, Vendor Advisory Representative noted the following;

- The VAC met on April 9th at NBRC. VAC members provide services under NBRC and is a liaison to them as needed.
- For more detailed information, please refer to the VAC minutes in the board packet on pages 26-28
- Each year ANCOR recognize a DSP of the year and the California winner is one of our own vendors. Hope Gutierrez from Bayberry, Inc.
 - She has worked in Napa for 30 years.

- David thanked Hope for being at the Board Meeting and recognized her for such a monumental achievement.
- ➤ Linda Plourde added Hope Gutierrez was the face of Bayberry Napa when SLS was first starting. She was supporting a gentlemen from 1998 to the day he passed away a couple of years ago. Hope was his care taker, and his support system. He trusted her. It's great to have someone stay in the field as a DSP, let alone at the same agency for 30 years. More than 400 people applied.

D. Legislative Advisory Committee Update -

Linda Plourde, Board Mentor noted the following;

- There are Senate Hearings on May 2nd and 9th.
- The Legislative Committee is focusing on DSP for a day, in August.
 - ANCOR will be setting the guidelines
- Our congressmen and legislators will be on recess in their home districts in August.

E. Client Advisory Committee Update -

Franklin Phillips, CAC Chairperson noted the following;

- The CAC met on April 24th, 12:30 pm 2:00 pm in Napa.
- Tobias Weare from State Council on Developmental Disabilities did a presentation on Self Advocacy and Courtney Singleton presented the 637 Waiver.
- > Gabriel Rogin noted it has been great hearing directly from the people we serve. It is clear that the committee emphasized the need for more job opportunities and housing opportunities.
- > Jeremy Johnson noted how impressed he was with the amount of participation.
- Angel Hixson noted the Board wanted to make sure to bring these committees back to NBRC to give clients and families more opportunity to be involved with what goes on here. There will be a fundraising committee coming soon.

DIRECTOR'S REPORT -

Gabriel Rogin, Executive Director noted the following:

- There is 2.1%, time limited bridge funding for some Service Providers. We are ready to implement this increase on 5/1/19. We will be sending out communication to those providers impacted.
- A lot of work was involved to secure the Line of Credit. One reason we were able to secure the loan was because we had a clean audit and we submitted it on time.
- Self-Determination orientations start tomorrow night and there at least 10 sessions.
- Cal Fresh will be available to many SSI recipients, which are many of the people we serve.
 Individuals may be eligible for both benefits SSI benefits and Cal Fresh starting June 1, 2019.
 Local CAL fresh offices will be available to provide support and the Regional Center can provide support as well.
- There was a news story about NBRC and our service system in general. The Board and
 community should know we take this very seriously and continue to take action to address the
 challenges in our system. There are also many positive, caring, compassionate people in our
 system. I'm proud of the work we do and we will continue to work hard every day to be help our
 clients thrive in their home communities. We're addressing the challenges and continuing to move
 forward.

- Mitch Freese spoke again saying the attitude from case workers needs to change.

	HIPAA and Business Associate Agreements: Thomas Maseda, Director of Administrative Services, and Rick Burkett, Director of Business Services, provided an overview of the privacy and security requirements of the Health Insurance Portability and Accountability Act (HIPAA). NBRC contacts with DDS, an originally regulated covered entity (CE). Service providers are business associates of NBRC. Business associates are responsible for protecting information of persons served and employees in accordance with the law, including designation of a security officer, designation of a privacy officers, and documented annual training to employees, email encryption services, and cloud backups. Personal identifiable information and protected health information are required to be secured via administrative and physical safeguards. Technical safeguards include password and data, and remote access policies, HIPAA-compliant email providers. Service providers expressed concern regarding cost and requested technical assistance from NBRC. Ali Tabababai suggested the VAC form a service provider subcommittee to address technology and security.
	Therap: Stan Higgins provided an overview of Therap, HIPAA-compliant online cloud-based electronic documentation with two-factor authentication. Therap provides a system to capture real-time documentation, tracking, reporting, and record-keeping that is accessible with internet-ready devices.

	Napa-Solano Vendor Group:
	 The Napa-Solano Vendor Group did not meet. Sonoma Vendor Group: The Sonoma Vendor Group met and discussed rates and staffing. NBI and BI met with Logan Pitts from Bill Dodd's office at BI. Trade Associations: CSLN: Linda is no longer on the board of CSLN. Renee Fannin will follow up with CSLN regarding a monthly report. ANCOR: EVV may be postponed to 7/1/20. ARC/UCP: May Revise does not include day programs, but does include supported living. SSI/SSA: Payee changes for former SDC residents are being processed. Ali recognized the local Napa SSA branch for its expedient processing of applications. New Leaf also sent acknowledgments to Mike Thompson's office. SSA is available to provide training.
	 David Mauger reported on the Board of Directors meeting. The meeting was in Santa Rosa on May 8. NBRC received feedback from parents regarding effective case management. January Crane and Lindsay Franco presented. Beth DeWitt provided an overview of client services. The Doug Cleveland Board Opportunity Fund was discussed specific to process. Courtney Singleton discussed the 637 waiver process. 3 prospective board members were introduced. 45 service recipients attended the Client Advisory Committee meeting.

NBRC Report: Gabriel Rogin announced that CalFresh benefits are available to many SSI recipients as of 6/1/19. Service recipients will need support with the application process. Service providers were encouraged to spread the word. Beth DeWitt continues to roll out self-determination orientations. In June 2018, there was a cash flow disruption at DDS, which affected NBRC service providers. NBRC now has a line of credit in place. Thomas Maseda and Saanen Kerson met with COAD. OES was also in attendance. PG&E will be enacting power outages when winds are 25MPH or more and there is high fire danger. **Legislative Committee:** The legislative committee discussed the importance of recognizing direct care staff. June will take place in Napa, July in Santa Rosa. Gabriel provided a summary of the May Revise. An 8% rate increase was not included, though time-limited targeted increases to some services beginning January 2020 were included. The May Revise also suspends the Uniform Holiday/Furlough Schedule until January 2021. There are also some provisions that would allow regional centers to fund services that are not currently authorized. Linda will send out a summary. She noted that the DDS portion of the summary is listed on pages 42-44. Linda noted that the push is to give an increase to all services. The Legislative Committee is organizing DSP for a Day in August. Services and Vendor Relations: There was no report. **NBRC Announcements** NBRC is undergoing an HCBS audit. January announced that nine service providers received funding for the third round of HCBS funding. NBRC is in the middle of case management time studies. Maura announced that the next employment task force is scheduled for Tuesday, May 28, in the Napa office. Maura urged service providers to send in SIRs on time. IV. Community Concerns/Clarifications **Agency Closures:** Service providers in attendance expressed concern and frustration over state rates and ongoing closures of services. V. NBRC Policies and **Procedures** There were no policy/procedure updates. **VI. New Business** VAC voting members: Members in Sonoma County would like some VAC meetings in Santa Rosa. The VAC will coordinate one meeting per quarter in Santa Rosa. The July VAC meeting will take place in Santa Rosa. Trauma Informed Care

During the month of April NBRC's Quality Assurance and Clinical staff hosted a training on Trauma Informed Care. Trauma Informed Care is an organizational structure and treatment framework that involves understanding, recognizing, and responding to the effects of all types of trauma. It does not mean identifying types of trauma people have experienced. It is assuming that most people have endured trauma and treating them accordingly. It includes ways to ask permission, offer control and find support. Trauma Informed Care emphasizes physical, psychological and emotional safety for both individuals being served and providers. NBRC vendors providing services in Enhanced Behavioral Support Homes or Community Crisis Homes, must take into account Trauma Informed Care when developing Individual Behavior Support Plans. Stay tuned as NBRC will have more trainings on this topic in the future.

PREVENTION

Observe, Decide, Act: How to Look For and Respond to Red Flags training was conducted by Dr. Gayatri Mahajan M.D., NBRC's physician. This training showed vendors what medical issues to look out for, how to respond quickly and which conditions are the most common and dangerous.
