# What is a "caseload ratio" and why is it important?

The Caseload Ratio represents the number of clients assigned to each Service Coordinator

It is considered an important indicator of providing good service to our clients

### North Bay Regional Center Caseload Ratios

March 2024 DDS Caseload Ratio Report (as of 3/1/24)

- Medicaid Waiver Caseloads
  - 2024: NBRC 1:66 vs. DDS Requirement = 1:62
  - ► Improved from1:76 in 2023 ★
- Age 0–5-Year-Old Caseloads
  - 2024: NBRC 1:40 vs. DDS Requirement = 1:40
  - ► Improved from 1:56 in 2023 ★
  - ► This measure reports the combination of Early Start & Young Children cases as required by DDS

# North Bay Regional Center Caseload Ratios

March 2024 DDS Caseload Ratio Report (as of 3/1/24)


- Complex Caseloads
  - ▶ 2024: NBRC 1:26 vs. DDS Requirement 1:25
  - Non-Compliant: 1:25 in 2023
- Low to No POS Caseloads
  - ▶ **2024:** NBRC 1:33 vs DDS Requirement 1:40
  - Remained compliant: 1:13 in 2023
- All Other Caseloads
  - ▶ 2024: NBRC 1:62 vs. DDS Requirement = 1:66
  - ▶ Improved from 1:77 in 2023 ★

#### North Bay Regional Center Caseload Ratios

\*NBRC estimates the need for 21 additional service coordinators to ensure we continue to make progress with our overall average caseload and prepare for future growth.




#### Regional Centers By Client Population

# Average Salary/Benefit Cost per Service Coordinator

Average Salary/Benefit Cost Per NBRC Service Coordinator

\$71,880 = Average NBRC Service Coordinator annual salary

\$24,439 = Average NBRC annual benefits (34%)

\$96,319 = Total average NBRC Service Coordinator salary/benefit package

\*The total average reflects the salary and benefits approved as of 01/2024. The salary/benefit package reflects an overall increase of \$8,854.

# Projected cost to meet DDS' Caseload Ratio Requirements

#### **Total Cost**

- NBRC will need 21 Service Coordinators to meet DDS' Caseload Ratio Requirements
  - ▶ 10 additional Service Coordinators to meet and maintain compliance with the DDS requirements for MedWaiver 1:62 caseload and All Others 1:66 caseload
  - ▶ 10 additional Service Coordinators in Early Start and Young Children to meet and maintain the DDS Requirements of 1:40 caseload and stay ahead of the client growth in this age group
  - ▶ 1 additional Service Coordinator to meet the increasing Complex Cases and maintain 1:25 caseload ratio requirement
- ► Total cost for 21 additional service coordinators = \$2,022,699

# North Bay Regional Center's Efforts to Meet Caseload Ratios

- As of May 1, 2024, NBRC currently had a total of 170 Service Coordinators on staff (increase of 16 SCs since last year)
  - ▶ 170 Service Coordinators
- ► NBRC is currently recruiting for 23 Service Coordinators
  - ▶ We have added 24 "growth" positions so far in the 23/24 Fiscal Year
- ▶ NBRC has hired 8 Service Coordinators since January 1, 2024
- We are working diligently to fill our vacant service coordinator positions. We recently hired a fulltime Senior Human Resources Generalist to identify and recruit potential applicants,.
- In addition, we continue to invest in 'agency branding' through online sources such as Indeed. We continue to offer an Employee Referral Award for employees who refer qualified candidates who are hired by NBRC.
- In addition, we recently contracted with an agency which specializes in case management employee recruitment.
